

# TOGETHER IN EDUCATION TELL US YOUR STORY SWEEPSTAKES

## OFFICIAL RULES

In the body of the e-mail, please include school name, coordinator name, and TIE code along with your TIE story. All e-mail submissions will receive verification of entry by May 6<sup>th</sup>, 2022. The email address used for submission will be the email address used for notification should entry be selected.
- **Entry by Mail:** In lieu of electronic entry method, you may also enter simply by hand-printing your school name, coordinator name, and TIE code on a single 3" X 5" card (the "Mail-In Entry") and mailing it to: TIE Tell Us Your Story, Harris Teeter, Inc., P.O.
