

**2024 Harris Teeter Sweepstakes
Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN.**

1) Eligibility: The Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina or South Carolina who, prior to the date of entry are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of DT Soccer, LLC dba Charlotte FC (hereafter, "Sponsor"), Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM"), Pro Soccer Development, LP ("MLSNP") and Player Development, LLC ("PDEV and together with MLS, SUM and MLSNP, collectively, the "MLS Entities"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, printers and advertising & promotion agencies, and any and all other companies associated prize providers, and any other person or entity associated with the development or administration of this Sweepstakes (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. 2) Sweepstakes Description: The 2024 Harris Teeter Sweepstakes ("Sweepstakes") Is available In a "Limited Time" format. A Limited Time Sweepstakes will run for a designated period of time, with defined start and end dates as noted below and in the description of the Sweepstakes at charlottefootballclub.com/harris-teeter-matchday-sweeps ("Sweepstakes Webpage"). For example, a Limited Time Sweepstakes might indicate that the entry period runs from 7/10/2024 through 7/16/2024; this indicates that this Sweepstakes starts at the beginning of the first day (12:00 A.M. Eastern Time ("ET") on 7/10/2024) and finishes at the end of the "through" day (11:59 P.M. ET on 7/16/2024), meaning this particular Sweepstakes will allow entrants to enter any time during the 7-day time period.

3) Sweepstakes Entry Periods Explained: The "Sweepstakes Period" for a Limited Time Sweepstakes is defined by the total time period that entries into the Sweepstakes will be accepted by Sponsor; during this time period, an entrant can visit the Sweepstakes Webpage and complete and submit the registration form to receive one (1) entry into the sweepstakes. Once the Sweepstakes reaches its end date (as noted on the Sweepstakes Webpage), the Sweepstakes Period will be over and no more entries will be accepted into that Sweepstakes. The Sweepstakes will consist of four (4) Limited Time Sweepstakes Periods.

4) How to Enter:
