Lipton[®] Together – Harris Teeter Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. The Lipton Together Harris Teeter Sweepstakes (the "Sweepstakes") is a game of chance.

1. Eligibility

The Sweepstakes is open only to individuals who are legal residents of the United States, residing in Georgia, North Carolina, South Carolina, Virginia, Maryland, Delaware and the District of Columbia, who are 18 years or older at the time of entry. 3. Sweepstakes Entry Period

<u>VIC Card Sign-Up</u>: Any time between June 16, 2021 and July 6, 2021 ("Sweepstakes Period"), each time you use your Harris Teeter[®] VIC Card at a participating Harris Teeter[®] store you will receive one (1) entry into the random drawing (limit one [1] entry per day per household). A free VIC Card can be obtained upon application at any Harris Teeter[®] store. VIC Cards that are stolen, fraudulent, tampered with or otherwise altered are not eligible for use.

Entry by Mail: You may also enter simply by hand-printing your name, complete address (including city, state and zip code), day and evening phone numbers, age, e-mail address and complete 11-digit VIC card number, on a single 3" X 5" card (the "Mail-In Entry") and mailing it to Lipton® Together – Harris Teeter Sweepstakes, Harris Teeter, Inc., P.O. POTENTIAL WINNER WILL BE NOTIFIED VIA E-MAIL AND/OR PHONE NUMBER PROVIDED DURING ENTRY REGISTRATION, AS SPONSOR'S DISCRETION. POTENIAL WINNER MUST RESPOND AND ACCEPT PRIZE WITHIN 48 HOURS OF NOTIFICATION. Potential winners must follow the initial prize claim instructions and any subsequent claim instructions, or the prize will be forfeited in its entirety. Concert experience will be in Charlotte, NC on July 23, 2021 or Raleigh, NC on July 24, 2021. Approximate retail value is \$599. Prize consists only of concert experience. Location and date of concert experience are to be determined by Sponsor and/or Talent, in their sole discretion. In the event the concert experience is not capable of being held live, Sponsor reserves the right, in its sole discretion, to substitute prize for another or equal or greater value.

Tickets are subject to program availability, venue capacity and age restrictions. Winner and guests must abide by all venue policies. Parking and travel not included and are solely the responsibility of winner and guest. No responsibility is assumed by Sponsors for canceled, delayed, suspended or rescheduled event. Any and all guarantees and warranties are subject to the manufacturers or service provider's terms and conditions, and the winner agrees to look

solely to such entity for any such warranty or guarantee claim. Prize is non-transferable. All federal, state and local taxes, if any, related to a prize are the responsibility of the individual winner. 9. Publicity

10. General Conditions

Sponsor and Administrator reserve the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor or Administrator's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Administrator in their sole discretion. Sponsor or Administrator reserve the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
